

QUESTIONS TO ASK BEFORE YOU DONATE

American universities failed to confront the alarming surge of antisemitism following Hamas's October 7, 2023 attacks, instead becoming pro-terrorist hotbeds hostile to Jewish and pro-Israel students. Alumni, as both influential advocates and financial contributors, have the power to push for critical reforms.

While some university leaders have demonstrated unwavering integrity in confronting pro-terrorist movements on their campuses, many others fall somewhere on a continuum. To determine where they stand, alumni should ask a series of critical questions before they donate to their alma maters.

JEWISH AND PRO-ISRAEL LIFE ON CAMPUS

- How does the college/university support Jewish life on campus?
- How has the campus Jewish population grown or declined over the past few years or decades? Did something catalyze this change?
- What programming and services exist for Jewish students?
- How does the college/university support programming and services for Jewish and pro-Israel students students?
- Does the college/university offer Jewish studies classes or other official coursework?
- Are there any organized pro-Israel and/or pro-Palestinian student groups on campus?
- Has your school ever faced a Title VI complaint over the treatment of Jewish students? How was that resolved? Are there any complaints pending?
- Has your administration received training from an organization like the Louis D. Brandeis Center on how to handle claims of antisemitism on campus?

OCTOBER 7TH, 2023 RESPONSE

- How has the university responded to pro-Hamas demonstrations, encampments, or vandalism targeting Jewish students and institutions on campus?
- Did faculty or administrators participate in or support protests that glorified Hamas or called for the destruction of Israel? If so, how did the school respond?
- Has the administration explicitly condemned acts of antisemitic harassment and violence in the wake of October 7, 2023?
- Were students who participated in vandalism, intimidation, or disruption of campus life held accountable? If so, how?
- Were Jewish students able to attend classes and campus events safely, or did they have to alter their routines due to threats or harassment?
- Have Jewish student organizations been consulted in shaping the university's response to campus antisemitism?

- Has the college/university or any of its schools or departments ever been asked to participate in

 Has the college/university ever faced pressure to divest its endowment from companies doing
- Has the college/university ever divested endowment funds or otherwise made investment decisions based on environmental, social, or corporate governance (ESG) considerations? Is there an official
- ESG policy?
 Has the college/university police force ever participated or considered participating in an international law enforcement exchange program?
- Have any student organizations passed resolutions calling for a boycott of Israel, Israeli companies, or Israeli products? Which groups, and when?

Does the college/university provide reasonable accommodations for religious students who

- Does the college/university offer kosher dining options?
- Does the college/university have a written policy in place protecting students from discrimination
